SITE APPLICATION CONDITIONS

1. Site applications must be approved by the event manager for the Peninsula Chamber of Commerce and all applications will be notified if accepted.
2. Only those products listed on the original site application and approved for sale can be sold. If any unapproved products are displayed or sold the site lease will be terminated immediately.
3. The site leaseholder is responsible for any damage to property or people caused through the operation of their site.
4. All site leaseholders must have a minimum of \$10,000,000 Public Liability Insurance and a current copy of their Certificate of Insurance must be submitted with the site application.
5. All site holders must meet Gosford City Council's Standard Electrical Specifications and the Australian Institute of Environmental Health Guidelines.
6. The allocated site must be left in a clean and tidy state.
7. The Peninsula Chamber of Commerce is indemnified against any claims relating to the site holders activities.
8. Vehicles can only access the festival area for unloading and reloading. Vehicles cannot be left in the allocated festival area during trading times and vehicle **access will not be permitted during the trading hours of 9am and 5pm** without permission.
9. The site allocated cannot be altered or changed without permission from the organizing committee. **Set up is required by 8.00am.**
10. All site fees must be paid on application for the festival.
11. Any breaches of this agreement can result in no further trading by the vendor.
12. All rubbish must be removed off site by the stallholder.
13. All stalls must be professionally presented.
14. Any signage must be approved by festival event manager
